("Z9 Project", "Us", "Our") collects, stores ,uses, shares and protects you information in connection with and in order to provide and develop Z9 Project's products, mobile applications, services and websites (together "Services") according to this privacy policy ("Privacy Policy").

All Z9 Project Services are governed by this Privacy Policy and by using or accessing Services You give consent to the processing, use and disclosure of your data. Please do not install or use the Services if you do not agree to this Privacy Policy.

1. WHAT INFORMATION WE COLLECT

We collect the following types of information:

1.1. Information you provide us directly:

- Your Facebook (or other social media network) account information, first and last name, image, e-mail
 you provide us for the purposes of registration, finding friends and sharing with them information about
 Z9 Project.
- Photos of your personal vehicles license plates for the purposes of the game process. In accordance
 with applicable legislation the license plates may be deemed as personal data, and in this regard you
 hereby consent, that your personal vehicles license plates may be used by Z9 Project and (or) other users (and this type of personal data may be processed) for the purposes of the game process, including
 after your termination of such license plates use in the game process, as well as after Your termination of
 the Services use.
- You can at any time withdraw your consent on use of your personal vehicles license plates (and this
 type of personal data processing) by contacting us at support@z9-project.com. In such case the photo
 of your personal vehicles license plates will be deleted from the Service within 30 days from the date of
 receipt of Your letter by Z9 Project.
- Photos of the license plates of the third parties vehicles for the purposes of the game process.
 Hereby You represent and warrant that (1) in accordance with applicable legislation license plates of

vehicles, which are provided to Z9 Project by You, are not deemed to be personal data, or (2) not-withstanding that in accordance with applicable legislation license plates of vehicles are deemed to be personal data, You have obtained the appropriate consent of the personal data subject on processing and transfer of his personal data in accordance with this Policy (the consent should be in the form and in compliance with procedure, required by applicable legislation), and taking photo and further use of such license plate photo will not contravene the applicable legislation. You hereby undertake to notify Z9 Project immediately if such personal data subject withdraws his consent.

- You hereby represent and warrant that You did not made any photos of vehicle license plates, where such taking photos is prohibited (e.g. private areas military objects).
- Z9 Project hereby disclaims any liability regarding privacy infringement of the third parties.
- Communications between you and Z9 Project, including but not limited by Services-related emails (e.g., account verification, changes/updates to features of the Services, technical and security notices).

1.2. Finding your friends in Z9 Project, Sharing your Z9 Project achievements, Inviting friends to Z9 Project:

- You can use "Recruit agents" feature to invite someone to Z9 Project. If you want to invite someone to Z9 Project, you may select a person and send an email from your personal account or a message through a third-party social media site. You understand and agree that you are responsible for any charges that apply to communications sent from your device, and because this invitation is coming directly from your personal account, Z9 Project does not have access to or control this communication.

1.3. Location Data:

• Z9 Project do not collect and do not process your location data.

1.4. Analytics information:

We use your information to perform our analytics and to enable analytics provided by third parties. We
use analytical information for supporting business analysis and operations, business intelligence, product
development, improving products and services, personalizing content, providing advertising, and making
recommendations. We collect and use this analytics information with analytics information from other
Users.

1.5. Cookies and similar technologies:

- When you visit the Services, we may use cookies and similar technologies like pixels, web beacons, and local storage to collect information about how you use Z9 Project and provide features to you.
- We may ask advertisers or other partners to serve ads or services to your devices, which may use cookies or similar technologies placed by us or the third party.

1.6. Log file information:

- Log file information is automatically reported by your browser each time you make a request to access
 (i.e., visit) a web page or app. It can also be provided when the content of the webpage or app is downloaded to your browser or device.
- When you use our Services, our servers automatically record certain log file information, including your web request, Internet Protocol ("IP") address, browser type, referring / exit pages and URLs, number of clicks and how you interact with links on the Services, domain names, landing pages, pages viewed, and other such information.
